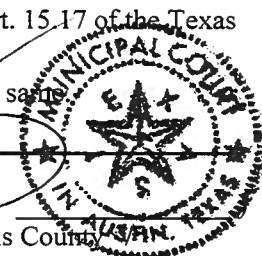

AFFIDAVIT FOR WARRANT OF ARREST AND DETENTION

The undersigned Affiant, who after being duly sworn by me, on oath, makes the following statement:
I have good reason to believe and do believe that

On or about 09/11/2012, in the incorporated limits of the City of Austin, County of Travis, Texas, did then and there commit the offense of:

DRIVING WHILE INTOXICATED - Offense Level: Class B

My belief of the foregoing statement is based upon personal knowledge information provided to me by Officer _____ an officer working for _____ who personally observed such offense.

I / Officer GILBERT 5346 observed the aforesaid accused driving / operating 2009 Black GMC Yukon TXLP BN5Y172 upon 500 Block Campbell, a public place in Austin, Texas.

I / Officer GILBERT 5346, stopped / contacted the said accused for the following reason: Subject was driving westbound in the 1000 block of W 6th St at a high rate of speed. I checked the vehicle at 45 mph using stationary radar. The posted speed limit in the 1000 block is 30 mph. The vehicle then moved from the left lane to the center lane without signaling any intent. The vehicle followed a slower moving car at an unsafe distance (less than 1 car length). In about the 1300-1400 block of W 6th St the vehicle drifted back and forth the left, crossing the lane line into the left lane as well as straddling the lane line as the vehicle continued westbound. In about the 1500 block the vehicle failed to signal intent again when it moved from the center lane to the left lane. When the vehicle stopped at the red light at the intersection of W 6th and West Lynn it failed to stop at the designated point, stopped well past the clearly marked stop line, past the first crosswalk line and into the intersection.

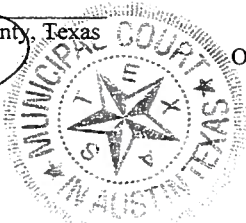
