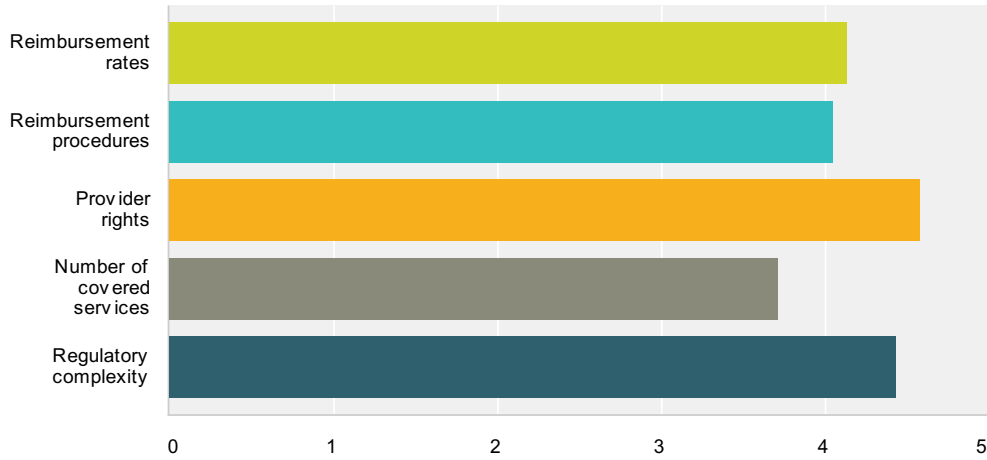


Q1 What are the biggest challenges Medicaid providers face today?

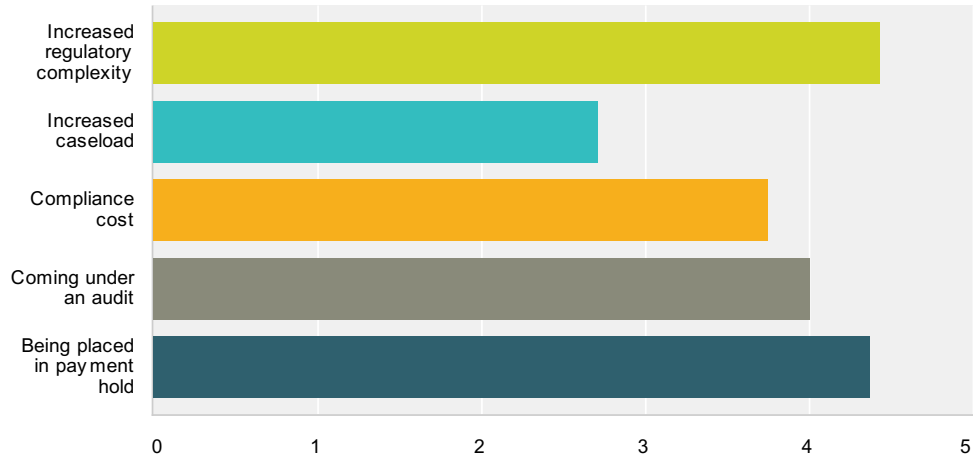

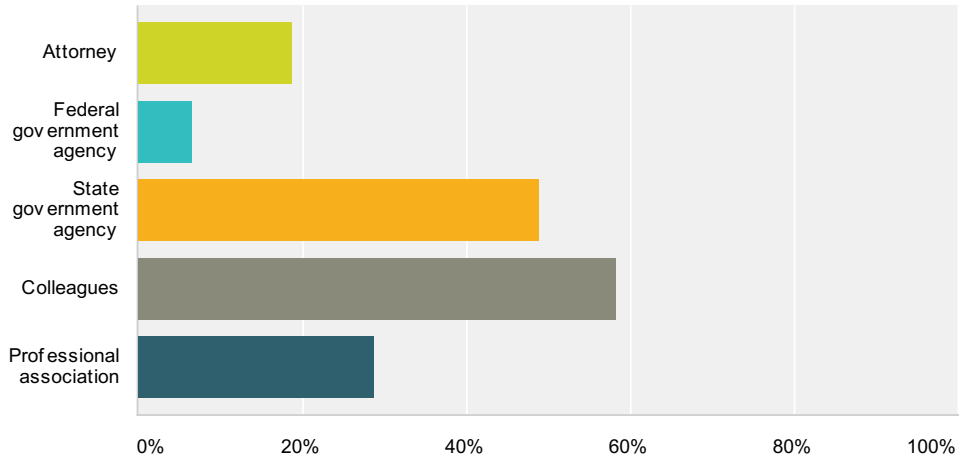

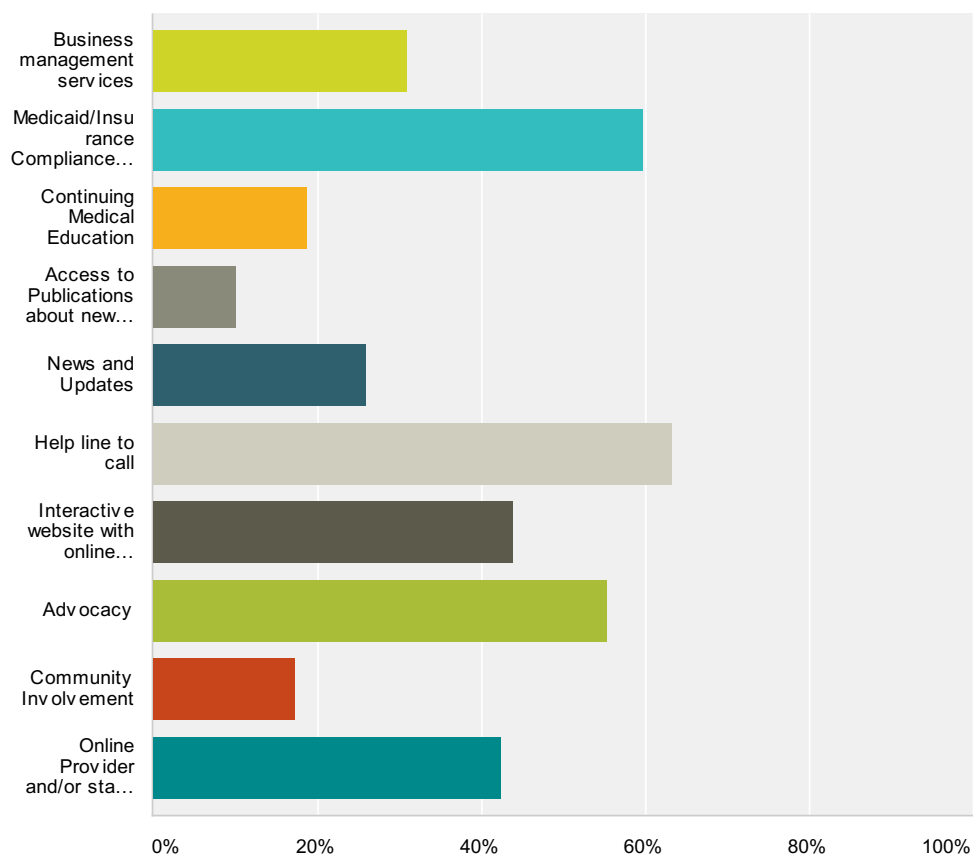

Q4 What services do you need to accomplish your goals?

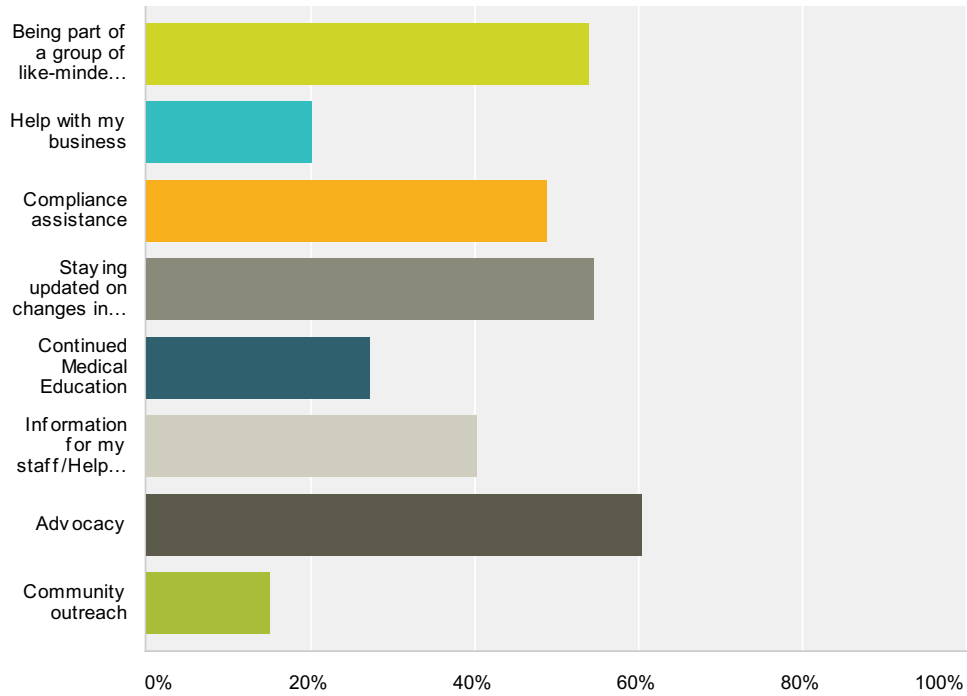

Q5 What do you think are the most valuable services a professional group provides its members?

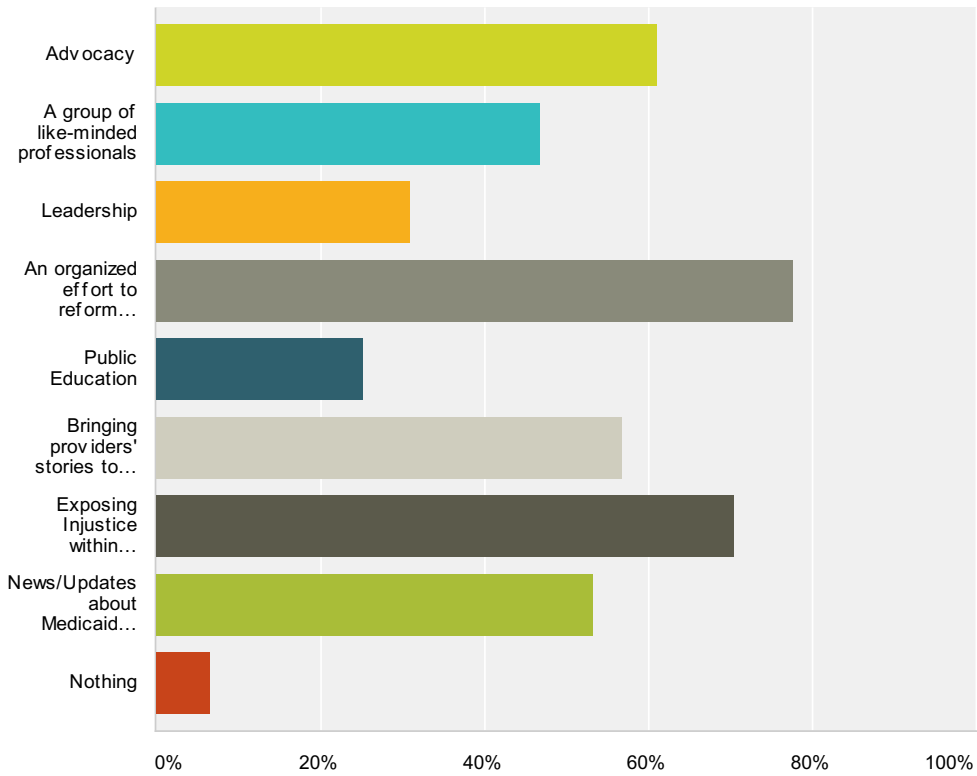
